Entry Fees/Refund Policy

First entry is \$20.00 per day; additional entries of same dog, same day are \$15.00. Entry fees include AKC recording/service fees of \$3.50 for first and additional entries. **Junior Handlers receive a \$5.00 discount for each class entered** (first entry \$15.00, additional entries of same dog, same day \$10.00).

If written notification is provided to the Trial Secretary prior to the beginning of judging for the day, a full refund of entry fees will be given for any bitch that comes into season, and a refund of entry fees, less \$5.00 per run for AKC fees and judging fees, will be given for any dog or handler that is injured or ill. Bitches in season are not to be on the show grounds.

ONLINE ENTRIES

Online entries are available for these trials through AKC's Online Entry service; you will need to have a My AKC account. Log in and go to My AKC, My Event Tools, Enter Agility Events. Or, go to https://www.apps.akc.org/apps/entry_management/ after you have logged in. During the first 48 hours after opening, the initial limit of entries per day designated as either online or paper will be as follows: for **each** trial, **100** runs/trial via online entries, **230** runs/trial via paper entries. If either form of entry has not filled at the end of the 48 hours time period, the club reserves the right to decrease or increase either one accordingly.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

Mixed breed dogs that have been listed with AKC Canine Partners may participate, provided their listing number has been recorded on the entry form. ****Please designate the dog's breed as "All American" on the entry form.****

Important Information for Exhibitors -- PLEASE READ!

Conditional, unsigned, incomplete, illegible, telephone, fax, e-mail or telegraph entries cannot be accepted. Entries not on official AKC forms, or photocopies of AKC forms without the agreement and rules on the reverse side of the official AKC entry form, are not acceptable. Returned checks do not constitute a valid entry and will incur a \$25.00 charge.

Owners are responsible for errors on entry blanks, for entering the same dog twice, or for entering a dog in a class for which it is not eligible, regardless of who makes such errors. Dogs wrongly entered in a class may not be transferred to another class after closing.

Entries sent by express mailing services MUST have the delivery signature requirement waived; otherwise receipt may be delayed. Entries will not be considered as being received until they are delivered to the address given on the entry form. Please note the opening date of June 17, 2024; no entries will be accepted before that date. Entries for a maximum of ten (10) dogs are allowed in one envelope; envelopes containing entries for more than ten dogs will be considered invalid, and will be returned to the sender. No hand delivered entries can be accepted until 8:00 AM on June 18, 2024.

SDTC is using a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 25 entries (runs) will be placed on each trial's wait list. All entries must have been received by the Trial Secretary prior to **Wednesday, July 24, 2024** at 6:00 PM. Any entries withdrawn, with notification to the Trial Secretary in writing (e-mail OK) by **6:00 PM on Monday, August 5, 2024** will be replaced by a wait listed entry, if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry; otherwise no refund will be given for withdrawn entries, except as specified above. Any wait listed entry that does not get into the trial will receive a full refund.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, or in the event a dog is absent (other than as specified on page 2), disqualified, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Confirmation of entry and judging schedule will be e-mailed (or sent by postal mail to the address on the official AKC entry form, if no e-mail is provided) after the closing date; if not received at least 7 days prior to the show, contact the Trial Secretary. **Acknowledgment of receipt of entries prior to closing will be provided if the exhibitor provides a valid e-mail address on the entry form, or includes a stamped, self-addressed postcard with entry.**

Spokane Dog Training Club, Inc. assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site and no refund of any fees paid will be made. All dogs must be on leash at all times except when in the ring or designated warm-up area. **THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.**

The safety of dogs is of primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. **SDTC reserves the right to remove a dog from an unsafe situation (e.g. a hot car) if needed.**

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Our judge, Mark Sjogren, is a VMO (Voluntary Measuring Official). Dogs at least 2 years old that have not completed the two (or three if a tie-breaker is needed) official measurements for a permanent height card WILL need to be measured at these trials by the judge. Dogs under 2 years old that have not had an official temporary measurement will also need to be measured.

Move-Up and Class Change Information

Dogs may be moved up to a higher class at the request of the handler, as a result of completing an agility title at an earlier event, provided that the request is made to the Trial Secretary, in writing (e-mail is acceptable), by 6:00 PM on **Monday, August 5, 2024**. If a dog finishes a title during the trial, the handler may move up for the following day(s) by filling out a move-up form (available at the event) and turning it in to the Trial Secretary within 30 minutes of the end of judging for the day.

The Regulations now allow exhibitors who have entered a class, for which they (or their dog) are not eligible, to change their entry to a class for which they are eligible, but the request for such a change must be in writing and must be submitted to the Trial Secretary at least 30 minutes before the start of the Trial. THIS DOES NOT MEAN THAT MOVEUPS CAN BE DONE AT THE LAST MINUTE – the moveup deadline is the Monday before the trials, as noted above. It does mean that if you have previously moved up, and then learn that your dog has not met the requirements for moving up, you may move back to the correct class; or, if you entered Novice A and the dog or handler is not eligible for the Novice A class, you may move to Novice B.

Volunteer Workers

As you probably know, there are quite a variety of tasks that go along with holding an agility trial, and we greatly appreciate volunteers to help share the work load. We will have a white board for worker sign-up at the trials. Workers will get a coupon usable toward future SDTC agility entries for each class that they work.

Site Information (NEW LOCATION!)

These agility trials will be held indoors on a sand/rubber surface. The ring size is 72' X 125'. Crating is available indoors adjacent to the ring; you may set up canopies outdoors in designated areas. **Prairie Sky is an active equestrian facility; dogs MUST be on leash except when in the ring, and must not be taken into areas where horses are present.** Of course, we know everyone will uphold the great reputation of agility exhibitors, and help us retain our trial site, by cleaning up after your dogs!

All participants must sign the Release Form included with this premium list. Please mail it in with your entries, or if entering online please mail to the Trial Secretary or bring it with you to the trials. We will also have the form available on site, and it MUST be signed before you run.

*****We will not be providing lunch, snacks or drinks at these trials. Exhibitors should plan to bring their own food and water.**

Directions to Show

From the west (Seattle/Richland), take I-90 to the Medical Lake/Cheney exit (270) going towards Cheney; go 0.2 mile and turn RIGHT on Hwy 904. Go 0.3 mile and turn RIGHT on Medical Lake-Four Lakes Road. Go 1.1 mile and turn RIGHT on Craig Road. Continue on Craig Road for 3.2 miles, going through the roundabout, and at the T intersection turn RIGHT on Thorpe Road and almost immediately turn LEFT onto Craig Road. Continue for 2.0 miles and turn LEFT on Highway 2. Go 1.0 mile, going through the roundabout, and turn RIGHT on Rambo Road. Continue for 6.5 miles on Rambo (the last ~ 0.4 mile is unpaved) and turn RIGHT at the T intersection with Lincoln Road. Go 0.8 mile on Lincoln and turn LEFT at the sign for Prairie Sky. Go past the driveway for the first house, stay to the RIGHT at the driveway for the second house and continue to the arena.

From the east (Spokane/Idaho/Montana), take I-90 to the Highway 2/Airway Heights exit (277), go through Airway Heights and through the roundabout at the Spokane Tribe Casino, and turn RIGHT on Rambo Road. Continue for 6.5 miles on Rambo (last ~ 0.4 mile is unpaved) and turn RIGHT at the T intersection with Lincoln Road. Go 0.8 mile and turn LEFT at the sign for Prairie Sky. Go past the driveway for the first house, stay to the RIGHT at the driveway for the second house and continue to the arena. (This is the simplest route; there are alternative routes that bypass Airway Heights congestion. Consult your GPS or Google Maps!)

From the north (Deer Park/North Spokane), take Highway 291 (Nine Mile Road) to Seven Mile Road, go 3.6 miles and turn LEFT on Garfield Road. Go 1.1 mile (making a right and left jog) and turn RIGHT on Lincoln Road. Go 1.3 mile (up a long hill and then curving to the left). Turn RIGHT on the unpaved road, which is the continuation of Lincoln Road. Go 0.3 mile and turn RIGHT at the sign for Prairie Sky. Go past the driveway for the first house, stay to the RIGHT at the driveway for the second house and continue to the arena.

BE AWARE: The lane from Lincoln Road to the arena has limited sight distance in places. It is wide enough for two cars to pass CAREFULLY, but not wide enough for RVs to pass each other. Please drive SLOWLY and watch for traffic.

Judging

Judging starts no earlier than **8:00 AM** each day. Judge's briefing and walk-through for the first class will take place prior to that time.

Anticipated Order of Classes (any changes will be published in the Judging Program)

Friday: FAST (all levels), STANDARD (Premier, Exc/Master, Open, Novice), JWW (Ex/Master, Open, Novice)

Saturday: T2B, JWW (Exc/Master, Open, Novice), FAST (all levels), STANDARD (Ex/Master, Open, Novice)

Sunday: T2B, STANDARD (Exc/Master, Open, Novice), JWW (Premier, Exc/Master, Open, Novice)

Awards

Rosettes will be awarded to 1st through 4th place in each height division in each Regular and each Preferred class. Green ribbons will be awarded to all dogs receiving qualifying scores.

Any exhibitor whose dog completes a title at these trials will receive a New Title ribbon. A Rosette and jump bar will be awarded to any dog completing a MACH or PACH at these trials. A qualifying score is required for all awards. All awards must be claimed at the show; none will be mailed.

*** If you think that you may complete a MACH or PACH at these trials, please let the trial secretary know ahead of time, so that we can plan to celebrate with you! ***

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights [in different classes] within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred classes and/or different jump heights within the same trial weekend, thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend. [EXAMPLE: if you are entering a dog in some Regular classes and some Preferred classes, submit one entry form for the Regular classes, and another entry form for the Preferred classes.] When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Entering For Exhibition Only (FEO)

FEO will allow exhibitors to work with their dogs in a trial environment. FEO is now allowed in ALL classes at the discretion of the club. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Participation in FEO is non-qualifying.

Effective July 1, 2024, FEO runs will be recorded in the catalog as Absent, instead of Excused.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of a class (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - Toys must be non-audible
 - Toys may not leave the handler's hand
 - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

Accommodations

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners SM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
